Scholarships

One hundred scholars awarded a record \$459,000 Sid Hancock, Scholarship Chair

The Garden Club of America has awarded a record \$459,000 for the 2024-2025 year to recognize the academic endeavors of 100 scholars—a banner year for the GCA's Scholarship Committee. Undergraduate, graduate, and post-graduate studies in areas including field botany and conservation horticulture will allow students to pursue their unique passions. This year, scholars ' field studies include coral reefs, industrial waterways, and the impact of US Army housing on the American landscape.

GCA's scholarships cover projects in the fields of botany, coastal wetlands, ecological restoration, desert studies, garden history and design, international studies, landscape architecture, conservation horticulture, horticulture, native plant studies, native bird habitat, pollinator research, environmental studies, and urban forestry.



Since 1928 when the first GCA scholarship, the Rome Prize Fellowship in Landscape Architecture, was established, over fifteen hundred scholars have been funded. The GCA offers twenty-nine merit-based scholarships.

"Our forward-thinking young scholars work diligently to find answers to the environmental issues we face," says the GCA Scholarship Chair. "They teach us that there is so much more to learn in our quest to restore, improve, and protect the quality of the environment. Their projects and research findings challenge GCA members to think differently, and we become better equipped to create our own positive change."



President's Report - Sara Woodhull

My Presidency in Review - The Garden Club of Dayton - 2022-2024

When Georgie asked me if I would consider First Vice President, I paused, it was an honor, but it seemed a daunting job. Georgie became my mentor and my guide and others joined in. This experience has been wonderful, hard, joyful and fun. Thank you all for your patience and support.

I do not have a slideshow like Georgie, so if you attended some of these events, picture them in your head - During these 2 years we had fun events - September 13, 2022, was our Flower Show "Cheers to 100 Years" the opening salvo of our almost yearlong celebrations. It was magnificent and we won judges' commendations for the Best in Show, Best if Hospitality, Best in Schedule and One of the Best in Overall Education - WHEW!!!

November, we celebrated our 100th with an elegant evening at the Grand Hall at Liberty Tower downtown, lots of flapper dresses and dancing, great food, wine and friends.

Program committee was creative and limber. We had day drinking to learn Cocktails with Botanicals, flower arranging with unusual plants, an education about cactus from Nancy White, continuing with member talents: Nancy Dankof, Gracey Weisbrod and Lisa Reeder how they manage color in their art and gardens and making bath salts at Cedar Ridge Lavender Farm. The Finale of the year was the installation of a Michael Bashaw interactive sculpture called "Wind in the Garden " and a beautiful mural by Jennifer Slayger. This \$100,000 gift to the City of Dayton in partnership with Five Rivers Metro Park was in honor of our 100th Anniversary.

In December 2022 I formed the Ad Hoc Committee to tackle all things about membership. 12 women worked very hard, going line by line through our Code of Regulations and our Operating Procedures. It worked, we now have transparency in how you get into the club and the requirements to stay in the club. As you can see from the list of changes in membership, members are choosing the membership category that best fits their current needs. This was a massive endeavor, and I am in debt to the determination of that committee and their resolve to clear up the long standing issues.

The second year has been more fun and more relaxed. We learned about the Boonshoft from Tracey Tomme, toured the Foodbank, Floral arranging by Cindy Garner to get us ready for another flower show, presentation from the Mission of Mary about their small nonprofit making big impacts, Pam Bennett, Master Gardener told us it is okay to mix up your gardens with natives and non-natives if that is your bent. Loads of fun was all things potatoes - who knew candy from potatoes and how to plant potatoes. Finally, to get ready for our Flower Show in May 2025, a presentation from Lynn Shiverick GCA Photography Judge on how to best take photos and what judges are looking for.

Here we are today, celebrating accomplishments and joys of friendship. But our big accomplishment, with lots of great publicity, was the work of the Projects Committee - giving away \$35,000 to the community of monies we raised from the Garden Gems Tour. Also, not as much publicity \$30,000 we gave to the Carillion, a planned gift from a former member to plant trees.

I would be remiss if I didn't pay a little homage to my mom, who was President 1963-65, I believe we are the first mother/daughter duo. As I said at the beginning, I was surprised and humbled when Georgie asked me to take the lead of a remarkable and talented group of women. Garden Club of Dayton honors and respects its members, we take care of each other and give back to our communities. Thank you for this honor.
